"The Five Solas of the Reformation" From the Intentional Interim Pastor October 2022

As we begin the Reformation month of October, it would be a good refresher course to reread or to read for the first time! the monumental work of Martin Luther, "The Bondage of the Will." In the introduction of this book, we read of the Five Solas of Reformation. They are: "SOLA FIDE, SOLA GRATIA, SOLI DEO GLORIA, SOLA SCRITPURA, SOLUS CHRISTUS!"

For those less astute in Latin, the meanings of these Solas are as follows: Sola Fide means by faith alone. Sola gratia — means by grace alone. Soli Deo Gloria — means Glory to God alone. Sola Scriptura — means by Scripture alone, and Solus Christus — means by Christ alone. These are the principles that we as Lutherans live our lives by.

Since we often don't consider these truths in depth at other times of the year, I thought it would be wise to bring them before you during this month, as we celebrate the Reformation and the courage and fortitude of Martin Luther who on October 31, nailed his 95 Theses on the Castle Church door in Wittenberg, Germany.

Sola Fide: Justification by Faith Alone

The "Central Teaching" of the Reformation was justification by faith alone. As the Lutheran Confessions says, "Our churches by common consent teach that men cannot be justified before God by their own strength, merits, or works, but are freely justified for Christ's sake, through faith, when they believe that they are received into favor, and that their sins are forgiven for Christ's sake, who, by His death, has made satisfaction for our sins." Luther himself later explains, Faith is a gift from God, and "...a living, bold trust in God's grace, so certain of God's favor that it would risk death a thousand times trusting in it.

Luther was not alone among the Protestant reformers. The Westminster Confession of Faith says, "Faith, thus receiving and resting on Christ and his righteousness, is the alone instrument of justification: yet it is not alone in the person justified, but is ever accompanied with all other saving graces, and is no dead faith, but worketh by love." Likewise, the Genevan Confession pointed out the necessity of those justified living by faith saying, "We confess that the entrance which we have to the great treasures and riches of the goodness of God that is vouchsafed us is by faith; inasmuch as, in certain confidence and assurance of heart, we believe in the promises of the gospel, and receive Jesus Christ as he is offered to us by the Father and described to us by the Word of God."

As the Scripture says: Even so Abraham believed God, and it was reckoned to him as righteousness. Therefore, be sure that it is those who are of faith who are sons of Abraham. And the Scripture, foreseeing that God would justify the Gentiles by faith, preached the gospel beforehand to Abraham, saying, "All the nations

shall be blessed in you." So, then those who are of faith are blessed with Abraham, the believer. For as many as are of the works of the Law are under a curse; for it is written, "Cursed is everyone who does not abide by all things written in the book of the law, to perform them." Now that no one is justified by the Law before God is evident; for, "The righteous man shall live by faith." (Galatians 3:6-11)

Sola Gratia: Salvation by Grace Alone

Another central cry of the Reformation was salvation by grace. Though the Roman church taught that Mass is a "sacrifice [which] is truly propitiatory" and that by the Mass "God...grants us grace and the gift of penitence, remits our faults and even our enormous sins" -- the reformers returned to the biblical doctrine of salvation by grace through faith. Our righteous standing before God is imputed to us by grace because of the work of Christ Jesus our Lord. In contrast to the doctrines of self-merit taught by Rome, sola gratia and the accompanying doctrines of grace were preached by all the reformers throughout the Protestant movement. As the Baptist Confession of 1689 says, "Christ, by His obedience and death, did fully discharge the debt of all those that are justified; and did, by the sacrifice of Himself in the blood of His cross, undergoing in their stead the penalty due unto them, make a proper, real, and full satisfaction to God's justice in their behalf;...their justification is only of free grace, that both the exact justice and rich grace of God might be glorified in the justification of sinners."

As the Scripture says: Blessed be the God and Father of our Lord Jesus Christ, who has blessed us with every spiritual blessing in the heavenly places in Christ, just as He chose us in Him before the foundation of the world, that we should be holy and blameless before Him. In love He predestined us to adoption as sons through Jesus Christ to Himself, according to the kind intention of His will, to the praise of the glory of His grace, which He freely bestowed on us in the Beloved. In Him we have redemption through His blood, the forgiveness of our trespasses, according to the riches of His grace, which He lavished upon us. (Ephesians 1:3-8)

Soli Deo Gloria! For the Glory of God Alone

The Reformation reclaimed the Scriptural teaching of the sovereignty of God over every aspect of the believer's life. All of life is to be lived to the glory of God. As the Westminster Shorter Catechism asks, "What is the chief end of man? Man's chief end is to glorify God and to enjoy him forever." This great and all-consuming purpose was emphasized by those in the 16th and 17th Centuries who sought to reform the church according to the Word of God. In contrast to the monastic division of life into sacred versus secular perpetuated by Roman Church, the reformers saw all of life to be lived under the Lordship of Christ. Every activity of the Christian is to be sanctified unto the glory of God.

As the Scripture says: Whether, then, you eat or drink or whatever you do, do all to the glory of God; Whoever speaks, let him speak, as it were, the utterances of God; whoever serves, let him do so as by the strength which God supplies; so that in all things God may be glorified through Jesus Christ, to whom belongs the glory and dominion forever and ever. He has made us to be a kingdom, priests to His God and Father; to Him be the glory and the dominion forever and ever. Grow in the grace and knowledge of our Lord and Savior Jesus Christ. To Him be the glory, both now and to the day of eternity. To Him be the glory in the church and in Christ Jesus to all generations forever and ever. Blessing and glory and wisdom and thanksgiving and honor and power and might, be to our God forever and ever. For from Him and through Him and to Him are all things. To Him be the glory forever. Amen. (I Cor 10:31; I Peter 4:11; Rev 1:6, 7:12; 2 Peter 3:1; Eph 3:21; Rom 11:36)

Sola Scriptura! By Scripture Alone!

Sola scriptura is the teaching that the Bible is the only inspired and authoritative word of God. It is the only source for Christian doctrine, and is accessible to all—that is, it is self-interpreting. "Scripture interprets scripture" is a governing principle of many Protestant denominations. Sola scriptura is sometimes called the formal principle of the Reformation, since it is the source and norm of the material principle, the gospel of Jesus Christ that is received sola fide ("through faith alone") sola gratia (by God's favor or "grace alone"). The adjective (sola) and the noun (scriptura) are in the ablative ease rather than the nominative case to indicate that the Bible does not stand alone apart from God, but rather that it is the instrument of God by which he reveals Himself for salvation through faith in Christ.

Solus Christus! By Christ Alone!

Solus Christus which means "Christ alone" or "through Christ alone". The Reformation was, more than anything else, an assault on faith in humanity, and a defense of the idea that God alone reveals Himself and saves us. We do not find Him; He finds us. That emphasis was the cause of the cry, "Christ alone!" Jesus was the only way of knowing what God is really like, the only way of entering into a relationship with Him as father instead of judge, and the only way of being saved from His wrath. Solus Christus is the teaching that Christ is the only mediator between God and man, and that there is salvation through no other, meaning that salvation is "by Christ alone"). To say Solus Christus does not mean that we do not believe in the Father or the Spirit, but it does insist that Christ is the only incarnate self-revelation of God and Redeemer of humanity. The Holy Spirit does not draw attention to himself, but leads us to Christ, in whom we find our peace with God.

These are the principles in which the Christian ought to live their life by. For they are the truth. May we always hold fast to the blessed truth and that is the Gospel of Jesus Christ.

Message from our Treasurer

MESSAGE FROM THE TREASURER

ESLC MEMBERS ---

First I'll give a quick update on our financial status. In August our contributions fell short of covering all our expenses, so we had to dip into the reserves a bit. So far, September looks like we will be close to meeting our needs with maybe just a small dip. The good news is we have not had to reach into our rainy-day funds. Some of our financial challenges have been created by some unexpected increases in bills. While we have seen several, three of them really stick out. 1) Our monthly water bill has seemed to be higher than in the recent past --- the trustees have aggressively looked for and repaired some items that may have caused this, and it appears they have resolved this problem, 2) Our monthly power bill has also been consistently higher than the past, especially with electricity. Looking at the data it shows we are using less than we have in the past but the cost per unit has risen to higher levels. So, not much we can do about this, 3) The third, and the main reason for this message is our property insurance. In preparation for 2022 we budgeted \$9,500 for the annual insurance premium which even accounted for a possible increase in cost from the year before. However, when our policy was adjusted for risks like the Marshall Fire and a sharp increase in its replacement value, we received our bill totaling \$11, 900. We dipped into our reserves and covered the bill.

I do not believe that we can sustain a \$12,000 annual bill, so a small group containing two officers and two trustees have engaged in a conversation with our agent for options to reduce our premium. We also have engaged with another insurance company for a competitive estimate. In a nutshell, it appears that the only way to reduce our costs back to our previous budget amount is to increase our deductibles. Currently our deductibles are set at \$1,000 for glass, \$1,000 for general claims, and \$1,000 for wind/hail. In order to substantially reduce our premium, we would need to increase our deductible for general to something like \$5,000 and our wind/hail to \$15,000. If that is the case and we decide to make this change, we would want to begin to build a savings account to offset this cost in the unfortunate event that we would need to file a claim. We have been very blessed in that we have filed only a couple of claims while at our current location. Using the above example, we would keep the budget line item very close to what it was last year. Keep in mind that our roof is now 19 years old (a recent inspection stated that it appears to be in good condition). We guess that the replacement cost would be \$60-\$70,000. The workgroup is still collecting data and we should have a full report ready for the October council meeting. We are then requesting to have a short Voter's Assembly meeting the following week. At this meeting we would like to present our data to the congregation and allow for further discussion. We would like to have a congregational consensus to either move forward, gather more data, or look for a different solution.

If you have any questions or comments, you may contact me or send a note to the secretary, and she will forward on to me.

*** NOTE - When I penned the "Message From the Treasurer" I was hoping that the contributions for the remainder of the month would help keep us on track for covering our needs. Unfortunately, our September contributions fell <u>far</u> below our expenses. I needed to use all the remaining funds in our payroll savings account. I also needed to dip into our Rainy Day Funds account. I will provide more details at the October 9th Voter's meeting.

Pastor Schultz is guiding us through this process.

At this first meeting, the team learned the definition, purpose, goals and the work to be completed by the taskforce. The purpose of the taskforce is to lead, equip, and assist the congregation in its interim journey using effectively the 5 developmental tasks under the direction of the IIP.

What are the 5 developmental tasks you ask?

- 1. Coming to Terms with History the committee is currently focused on this first with the following activities:
 - a. Cosmetic issues These include updating the picture board, mailboxes, membership list, update time talents, and treasure, update website and media, and updating church history information.
 - b. Mission/Vision -This includes reviewing our identity, mission and vision statements, faith statement and goal setting.
 - c. Governance This includes reviewing and updating our Constitution and By-Laws (if needed) and evaluating the decision-making structure of the church.
 - d. Financial Stability This includes developing a realistic and balanced budget that is currently being completed by the Church Council.
 - e. Pastoral Search and Transitional Care This includes determining the type of pastor we want to call and preparing turn over materials for the new pastor.
- 2. Discovering a New Identity
- 3. Leadership Changes During an Interim
- 4. Renewing Denominational Linkages
- 5. Commitment to New Directions in Ministry

We will be meeting monthly and will give updates on our progress. If you have any questions regarding this team and its tasks feel free to ask any team member.
